Cat Action Team Annual General Meeting

6 April 2014 at 2 PM

St. Eleanor's Community Centre

Attendance: Thirty-two people were in attendance.

- **1. Welcome/President's Report:** Krista Adams, President welcomed everyone and gave the president's report.
- **2. Approval of Agenda 6 April 2014:** It was moved by Mary Gallant, and seconded by Carol Palmer. The motion was carried.
- **3. Approval of Minutes of 7 April 2013:** Donald Turner moved we amend the minutes, which read:

In response to Pat Srebrnik's assertion that in 2012, revenue from grants was higher than any prior year, one group of members objected that CAT is becoming too dependent on grants revenues, these members also predicted that the current application to PetSmart Charities of Canada was likely to be unsuccessful. One member, for example, argued that recent posts on CAT'S facebook group would result in the grant being rejected.

Change to: In response to Pat's Srebrnik's assertion that in 2012 revenue from grants was higher than any prior year.

Carol Palmer seconded the amendment. The motion was carried.

The motion to approve the minutes was moved by Carol Palmer and seconded by Donald Turner. The motion was carried.

- **4. Financial Report:** Michelle Burge of MRSB presented the financial report and answered questions. It was moved by Bob Stanley that CAT accept the financial report as presented and seconded by Geoff Lindsay. The motion was carried.
- **5. Committee Reports:** Krista Adams stated that all the reports were included in the handouts. Krista also stated that she wished to acknowledge and thank the 4-H group and the Summerside Intermediate School group who raised money to spay/neuter

cats in their areas.

6. Report from Dr. Peter Foley on TNR Statistics: Dr. Foley presented the TNR report for 2013. He stated that in 2013, 855 cats were spayed/neutered through CAT, giving a grand total of 9,338 cats spayed/neutered through CAT, as of the end of 2013. He stated that cats were being tested for FeLV and FIV at AVC on the Saturday neuter days and throughout P.E.I. on an as needed basis. Diane Minick asked why the neuter/spay days were decreasing on Fridays at AVC. Dr. P. Foley was not sure of the reason.

7. Election of Board Members: There were 3 vacant positions on the board of directors. Gayle Adams had been voted on to the board, by the board of directors during the previous year, to complete the term of another board member who had resigned. There was still one year to be completed on that two-year term. After Gayle Adams left the room, it was moved by Geoff Lindsay and seconded by Donald Turner that Gayle Adams complete the last year of that 2-year term. The motion was carried.

Bob Stanley and Paula Connolly put their names forward prior to the AGM and Cathy Costain offered from the floor to serve on the board. There were no other nominations. With Bob, Paula and Cathy, the board had its maximum number of 10 board members.

After nominations ceased Carol Ann Desjardins spoke about reducing the number of board members for Cat Action Team. After some discussion from the floor, Carol Ann Desjardins moved to reduce the number of board members to six and the board to look into making changes to the by-laws. Donald Turner seconded this motion. The motion was carried.

- **8. Auditor for upcoming year:** After a brief discussion it was moved by Gayle Adams and seconded by Candy Gallant that the Cat Action Team continue to retain the services of Michelle Burge from MRSB. The motion was carried.
- **9. Adjournment:** Carol Palmer moved the meeting be adjourned at 15:50 hours.

Historically, only approximately seventy percent of board members show up for each meeting and of that a lesser percentage carry the heaviest work load of the board.

Message From Secretary

I wish to ask for a huge round to applause to outgoing board members that have served in the past two year. When we came on the board in 2013 cash on hand was approximately \$19,000. At last years AGM, we put that number up by approximately \$29,000 on hand. These numbers include left over grant money. This year we have approximately \$40,000 cash on hand. About half of this is grant monies but the balance is for spring TNR. This is something that CAT has never experienced before.
